The Governing Board of Westwood Estates Fire District will meet in **Regular Session on Friday, September 15, 2016, at 10:00 a.m. The meeting will be held at City of Flagstaff Station 1 – 1972 S. Thompson St, Flagstaff AZ 86001.** Members of the Governing Board will attend either in person or telephonically. The Board may vote to go into Executive Session on any agenda item, pursuant to ARS 38-431.03(A)(3) and (A)(4) for discussion and consultation for legal advice from the District's attorney on matters as set forth in the agenda item. Therefore, pursuant to A.R.S. 38-431.01(G), action taken as a result of public comment on non-agendized topics will be limited to directing staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date. If warranted, issues raised may be placed on the agenda of a future meeting.
