Sharing latest news from Command Staff with incoming shift



Member issues: Based EMS not being recognized. Flagstaff Fire and Summit led the charge for inappropriate PPE for calls that initiated MOU's

MOU with Coconino County Health Human Services to facilitate data to where abouts received positive test. Been receiving 10 days after call.

Rolled back participation for wildland call outs. Prioritizing staff from exposure at camps, etc. Local area calls are being responded to.

Deputy Chief Staskey (Operationally)

High risk EMS calls: flu like symptoms call, decon truck and station.

Geared down outside contacts/visitors to stations

Off Duty staff using work out rooms

Today was a call from Dr Croft to firefighters on education of ongoing issues. It has been shown vapers are higher probabilities of catching COVID 19

Deputy Chief Wilson:

Assuming all calls are COVID19 calls. CDC has reported 20-24% cases are showing A Symptomatic.

Battalion Chief Palm

There are new uniform changes in the stations

Temperature checked 3 times/day. Must go home if 100.4 temperature

There was a flu strain. Couple staff members were tested negative for COVID19.
