Paul Summerfelt from the City of Flagstaff Fire Department informed the Fire Board that he was retiring, and he introduced Paul Oltrogge as the new FMO. FMO Summerfelt and Oltrogge discussed the high fire danger, fire restrictions for the area, current weather conditions and signage that are going up around naval observatory.

The no camping signs have seemed to help and has changed the camping habits of most. They also discussed the proper route to use for reporting unlawful camping in the area. Call the nonemergency phone number for Coconino County Sheriffs Department (928-774-4523) describe the



issue, they should send the call to Coconino County National Forest to dispatch Forest Service law enforcement. Forest Service is still installing signs.

The Forest Service has been doing a great job of relocating people who are camping in the no camping areas. The Fire Board appreciated the help of the Forest Service and of FMO Summerfelt. They are looking forward to working with FMO Oltrogge.
