The Governing Board of Summit Fire & Medical District will meet **in a Regular Session on Wednesday August 15, 2021, at 3:00 p.m. The meeting will be held in person and remotely through technological means (see above).**

However individual Board members may be permitted to respond to criticism directed to them. Therefore, pursuant to A.R.S. 38-431.01(H), action taken as a result of public comment on non-agendaized topics will be limited to directing staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date. If warranted, issues raised may be placed on the agenda of a future meeting.
