 - BC Zambeck reported:
 - Run report for November 2024. Total of 130 incidents, with 93 being emergent calls. Call distribution is as follows: District 31 had 30 calls, District 32 had 72, and District 37 had 28.
 - Avg response times: Sta# 31 at 7.25 min, #32 at 5.39 mins, #33 at 7.54, #37 at 7.59.
 - Auto aid given by us: 22; Auto aid we received: 6.
 - Introduced new tool, Glidescope, for the paramedics to use with intubations. It has a computer screen connected to a camera on the scope so you can see inside the patient's airway for placement of the intubation tube.
